Dear Mr. Leo Padilla:

I understand that you fight with your comrades for claiming the reparation to the damages and lots of atrocity committed by Japanese emperor's army, against Japanese government.

We, some conscientious Japanese Americans and Japanese with the sense of justice and equity, fully agree and support your right action.

Recently, in Japan, many cover-uped gruesome historical facts, ^{exposed by brave writer} hidden long time slyly by Japanese emperor's family headed Hirohito and his heir: Akihito together with their S.S. (just like Hitler's body-guard party) ruling conservative party called Jiminto, which are of during and just after World War Two: for instance;

1. The pacific war, provoked by Hirohito's imperial forces attacking Pearl Harbor, Malay and P.I. had been conspired by Hirohito, then, supreme commander and generalissimo of Jap. army & chief priest of Jap. chauvinistic Shinto-cult which is still believed even now by 90 percent of Japanese, for one year before the sneak attack and commander Hirohito himself encouraged Jap. general Tojo and admirals Nagano and Yamamoto to sign the final Go on Dec.7, 1941.

2. When imperial Japanese surrendered at last to MacArthur in August, 1945, Hirohito persistently insisted to continue to fight against US & allied forces by desparate Kamikaze fightings, thus killing unnecessary youths of both sides, just for the aim of "world conquest by divine character of Japanese emperor" which was and even now dictator in substance. By the inevitable presses of Atomic bombs, Hirohito was forced to accept the unconditional surrender, that meant at first, the punishment of death by hanging of Hirohito and his imperial members who were all generals or admirals of the imperial forces then. But, Kido, his top-aides like Haldmen to Nixon, and some imperial crony had framed up the myth that Hirohito was against the War all the time and initiated to close the War, disregarding himself, that are still taught in school-text books plausibly, but some brave historians like David Bergamini, USA and Frank Hosono, Jap. American anthropologist and critic broke up the framed-up Japanese imperial taboos by their book recently and disclosed the hidden facts that Hirohito and his imperial family were the real agitators who should be held full responsible for every War-crimes and many brutal atrocities and unhuman massacres from anti-China invasion war, 1935 till end of WW Two, 1945. Even Japanese democrat scholars like prof. Kiyoshi Inoue of Kyoto University supported fully these new historical facts.

Just after the War, when MacArthur and allied democratic powers conquered Japan, Hirohito rushed to the liberator, MacArthur at GHQ personally and entreated him to save all imperial family who are all leaders of imperial forces, from death punishment, shoving all responsibility to Tojo and other

military top-leaders smartly, after Hirohito's favorite elocution to make the same aristocratic conqueror believed of Japanese imperial myths and taboos.

Hirohito and all imperial family have been acquitted by MacArthur very mysteriously and their lives were saved from the gallows, just before the closure of Far East Wartime Tribunal at Tokyo in 1948.

Now that some Japanese American group, headed by William Hohri filed the suit \$25 billion for the reparation and solace of the damages they suffered in the relocation camps during Wartime with Federal dist.court in Washington. We believe, however, this kind of damage suit should have been filed against ex. almighty dictator of Japan Empire, Hirohito and imperial family, headed now by prince Akihito both of whom still dominate the democratized Japan (superficially though), and who themselves really provoked the war by sneak-attack against Pearl Harbor while camouflaging the peace talks under two Jap. envoys Nomura & Kurusu with secretary of State, Hull in Washington in 1941.


